



CARTIER CLOSES A \$100,000 PRIVATE PLACEMENT WITH SIDEX

Val-d'Or, Canada, June 12th, 2015 – Cartier Resources Inc. (TSX Venture Exchange: ECR) (“**Cartier**”) announces the closing of a private placement with SIDEX, s.e.c. for gross proceeds of 100 000 \$. In total, Cartier issued 1 000 000 units (the “Units”) at a price of \$0.10 per Unit, with each Unit consisting of one (1) common share at a price of \$0.10 per share and one (1) common share purchase warrant, each warrant entitling the holder to subscribe for one (1) common share at a price of \$0.13 for a period of twenty-four (24) months following the closing date. This placement was completed under the SIDEX “2015 Field Action” financing program.

The securities issued under the private placement are subject to a four (4) month statutory hold period.
